i) Toiledau Cyhoeddus Tresaith *Public Toilets*

Nododd y Clerc ei fod wedi gohebu â Paul Williams i ofyn am ragor o wybodaeth ynghylch amcangost cynnal y tai bach hyn ynghyd â'r amserlen ar gyfer gwneud penderfyniad terfynol yn y dyfodol agos.

The Clerk noted that he has corresponded with Paul Williams in order to ascertain further information regarding estimated costs for maintaining these toilets as well as a timetable for decision making in the near future.

ii) Cyfrifon y Cyngor/Council Accounts

- i) Diogelwch ar yr A487/*Road Safety on the A487*
Nododd Teifi fod dwy ddamwain wedi digwydd rhwng Tanygroes a Sarnau yn ystod y mis diwethaf. Y digwyddiad mwyaf difrifol oedd yr un wrth ymhl ei gartref pan darodd beic modur wal wrth geisio goddiwedd yd ar y cornel hwnnw. Cytunwyd yn unfrydol y dylai'r Clerc ohebu unwaith eto â'r Asiantaeth Prifffyrrd yng Nghonwy er mwyn eu hatgoffa o'r angen sydd am linellau gwyn dwbwl er diogelwch gydwyr.
Teifi noted that two accidents had occurred between Tanygroes and Sarnau during the last month. The more serious incident happened by his farm when a motorcyclist struck a wall when attempting to overtake at that corner. It was unanimously agreed that the Clerk ought to correspond with the Highways Agency in order to remind them of the need for double white lines to promote driver safety.
